## MEMBERSHIP MINUTE "WHAT DOES ROTARY MEAN TO ME?" EDFONG



I was born and raised in Honolulu, graduated from McKinley High School and attended the University of Hawaii at Manoa. My initial idea was to study engineering, but I found that the world of business was much more interesting. During my freshman year, I also worked part-time at the UH Bookstore on campus and then I started a second part-time job as the book-keeper for Ka'leo, the UH student newspaper. The more I studied, the greater my focus grew on the elements of a successful career. I also noticed that an Accounting Degree was a very common educational thread woven into the achievements of most successful business people. In my junior year, I had a terrific opportunity to work part-time for the Bank of Hawaii in their check clearing proof department. I really enjoyed this job, despite the 5:00pm-9:00pm Monday thru Friday work schedule, and was promoted to supervisor in my senior year. I graduated with a Bachelor of Accounting degree in 1962 and worked for local CPA firms to get experi-

ence. In 1965, I passed the national CPA examination, became a certified CPA and joined the firm of Leong & Leong. In 1966, I became a partner at the firm and in 1967 I married my schoolteacher fiancée. In 1979 I returned to UH Manoa to earn my Masters of Business Administration. In 1980 my CPA firm became Leong & Fong and in 1981 I graduated with an MBA.

However, from my days at McKinley to today, I have always been involved in community service and was very active in the Jaycees until I became a "Jaycee Rooster" at 36 years of age. My children's godfather, CK Huang, was a member of the Rotary Club of Waikiki and sold me on the greatness of Rotary. However, this was in 1975 and I didn't live or work in the Waikiki district. Leong & Leong was located on Ward Ave., but on the "wrong side" of Ward to meet the district criteria for the Ala Moana Club. Clarence Tam was my hard working sponsor and he obtained a district exemption and I became a

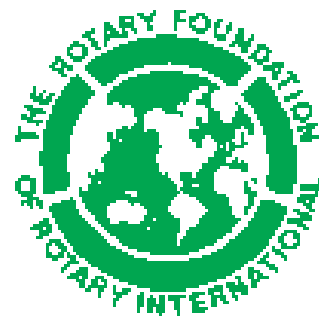
